Conditions of Entry / Conditions of Sale

These conditions of entry and conditions of sale are necessary to ensure the safety of our staff and visitors, and the safekeeping of arms and ammunition stored on site.

Praesidia Alliance Limited [PAL] is located on Bypass Road, Ma'ufanga (blue building opposite Cockers Gas Station)

Arms & Ammunition Dealer Business Hours:

10am to 4pm Monday to Friday (excluding public holidays)

* Entry / Sales Outside These Hours Is Not Possable *

- PAL is not a public entry gun shop, goods are not on display; PAL is a supply service for licenced firearm holders only
- only registered customers (licence holders who have been issued a PAL Customer Card) may enter the PAL building for the purpose of purchasing items relating to their firearms licence; no friends or relatives or guests of licence holders are permitted to enter the building with the licence holder
- licence holders are required to obtain a PAL customer card before purchasing any goods; obtaining a customer card is a simple process of filling out a form at the PAL administration office (copies of ID and firearm licence will be taken, a photograph of the licence holder will be taken) and then being issued a customer card with reference number
- firearms, ammunition, and related equipment requiring licencing, may only be sold to persons holding a current PAL customer card, current firearms licence together with other related permits issued by Tonga Police; licence holders need to present their licence, related permits, approved ID, and PAL customer card (original documents, not copies) to PAL staff at the time of each and every purchase; insufficient or irregular documentation or ID will result in equipment supply being declined

taking photo's / recording videos within the PAL building is strictly prohibited



- any person taking photo's or recording videos will cause a security incident; in such a case PAL will cancel any involved licence holders PAL Customer Card no customer card, no service.
- registered customers need to go through a security checkpoint before being escorted into the secure area customer supply room; weapons detection scanners are in use at the checkpoint
- entry to the secure area customer supply room only 1 licence holder will be permitted to enter / remain in this room at any time is by invitation following the security checkpoint process, PAL staff may withdraw permission to enter, or may withdraw permission to remain in, the customer supply room at anytime; licence holders should immediately leave the secure area if requested
- firearms and/or ammunition may not be carried into the PAL building unless a prior special appointment time has been made in advance and firearm / ammunition being brought in is within a carry bag/s, not in open view. Firearms and/or ammunition sold to a licence holder will be provided in a carry bag at the time of sale to enable discreet exit from the PAL building and property. These requirements are required to avoid causing unnecessary concern to security staff on site and members of the public
- any person (including licence holders) who openly displays a firearm within the PAL building, car park, or property, will cause an immediate high priority security incident; in such a case PAL will cancel any involved licence holders PAL Customer Card no customer card, no service.
- PAL staff will not discuss firearms, ammunition, or service, details with unknown persons over the phone, in all cases initial enquiries must be directed to -
